Tips for targeted risk control

To identify claims with potential for high risk, focus on claims that involve acute injuries, claims that reveal a large increase in pharmacy spend, or claims with annual pharmacy costs at or above the \$3,000 level. Other good identifiers include multiple medications, especially multiple analgesics, and cases that are still open a year or more later from the date of injury. If solving the prescription drug abuse epidemic was easy, you wouldn't be reading this. But the fact is, we're nowhere near finding an answer. Drug overdose deaths and opioid-involved deaths continue to increase in the United States. According to data on the website for the Centers for Disease Control and Prevention, the majority of drug overdose deaths – 66% – involve opioids.

The national opioid epidemic escalated in 2016. That year, the number of overdose deaths involving prescription opioids and heroin was five times higher than in 1999. Today, 115 Americans die every day from an opioid overdose.

While our country continues to debate how to get the problem under control, you can take action now.

Psychosocial assessment and other risk scoring tools can also be applied to screen for barriers to recovery such as depression, anxiety and substance abuse disorders.
